1. Data controller

2. Personal data

PROMOCIONES VETERINARIAS, SA shall collect only personal data that are adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed, as applicable in each case.

The user guarantees the authenticity of the data provided and shall be solely responsible for any false or inaccurate statement.

It is not necessary to be of legal age to use and visit this website. PROMOCIONES VETERINARIAS, SA only intends to process personal data of persons over 18 years of age with full legal capacity. PROMOCIONES VETERINARIAS, SA does not intend to collect personal data from minors.

3. Purposes of processing

Personal data shall be processed by the data controller for the following purposes, as applicable in each case:

- Reviewing and, where appropriate, investigating and responding to messages received.
- Responding to persons who have contacted PROMOCIONES VETERINARIAS, SA with a potential interest in becoming its customers or suppliers.
- Reviewing and assessing the information and/or documentation provided, with the aim of participating in a personnel selection process and/or assessing the suitability of the profile for the company. Should it be of interest to PROMOCIONES VETERINARIAS, SA, the company will contact the interested party with the intention of assessing their application. If the candidate expressly confirms it, PROMOCIONES VETERINARIAS, SA may keep the personal data for an additional period of 1 year from receipt.
- Preventing, detecting and controlling abuse and fraud committed on or through the website.
- Managing compliance with legally stipulated obligations.

4. Legal basis for processing

The legal basis for the processing of personal data shall be compliance with a legal obligation, where the data have been provided for the management of compliance with legally stipulated obligations. The processing of personal data for the aforementioned purposes is necessary for PROMOCIONES VETERINARIAS, SA to comply with the obligations imposed on it by the applicable legislation.

Furthermore, the legal basis for the processing of personal data shall be the application of pre-contractual measures requested with the stated intention of the interested party to enter into a contract with the data controller, where the data have been provided for the following purposes:

Finally, the legal basis for the processing of personal data shall be the legitimate interest of the data controller, where the data have been provided for the following purposes:

- Reviewing and, where appropriate, investigating and responding to messages received. The legitimate interest of the data controller consists of duly attending to the persons who contact the company.
- Preventing, detecting and controlling abuse and fraud committed on or through the website. The legitimate interest is based on the data controller's desire to keep the website a secure site.

5. Recipients

PROMOCIONES VETERINARIAS, SA shall not disclose personal data to third parties, except to the competent authorities and/or bodies in the event of a legal obligation, as well as to service providers and third parties necessary for the management and execution of contractual relationships and/or the processing purposes defined herein.

6. Retention periods

Personal data shall be processed for as long as necessary to fulfil the processing purposes indicated. In any case, personal data shall be kept for the entire period of time during which liability may be claimed from the data controller as stipulated by the applicable law, proceeding, where appropriate, to block the data until the corresponding limitation period has elapsed.

7. Users' rights

We inform you that at any time you may exercise the rights of access, rectification, erasure, restriction, objection and portability with respect to your personal data provided for in data protection regulations, by sending a letter to Carrer Mataró, 1 (08500) Vic, Barcelona, Spain, or by email to info@provetsa.com.

Specifically, you may exercise the following rights:

- Access your personal data.
- Rectify inaccurate or incomplete data.
- Request the erasure of your data when, among other reasons, the data are no longer necessary for the purposes for which they were collected.
- Exercise the restriction of data processing when any of the conditions provided for in data protection regulations are met.
- In certain circumstances and for reasons related to their particular situation with respect to the processing of their data, interested parties may object to the processing. In these cases, PROMOCIONES VETERINARIAS, SA will stop processing the data, except for compelling legitimate reasons, or the exercise or defence of possible claims.
- Obtain human intervention, express your point of view and challenge automated decisions taken by PROMOCIONES VETERINARIAS, SA, where applicable.
